(v) In case of non-declaration of last result the last declared result shall be considered for Nomination but not below the result of the qualifying exam.

(vi) It is pertinent to mention that in the event of getting compartment/re-appear or failed in the preceding class/semester, the nomination of the candidate which was made prior to the declaration of his/her result will cease to exist.
